TOPIC:

Financial Report

DISCUSSION:

Al Martin presented the Financial Statement for the period ending February 28, 2022. Net surplus the end of February 2022 was \$43,818, compared to \$25,169 in 2021. Overall cash balance is up \$60K from last year. Lodging revenue up \$45K. Operating expenses are inline with budget. The room tax receipts for 2021 were the highest in CVB history.

Dan Spedden reported that \$500K from Washington County's ARPA Fund was deposited yesterday. The monies will be used to assist event planners in getting their events started up again, as well as supporting new events, marketing, and other sponsorships.

WELCOME

Board of Directors and Advisory Board

Dan Spedden welcomed new Board member, Jeremy Hulse, and Advisory member, Brittany Wedd.

President Report

Dan Spedden shared he attended Washington County Day in Annapolis, which was well attended by legislators. Thirty-three bills are being tracked through the legislature, including a film tax credit for rural productions and a Maryland vacation 626 Senate Bill which would give \$1000 back in lodging expense.

Mr. Spedden mentioned an amendment to the Maryland Great Outdoor, which would include funds to destination marketing organizations to promote the State parks.

Mr. Spedden recently testified at a hearing on behalf of Stoney Creek Farm to be the first agritourism resort. This would be a \$12-15 million investment. April 9 it will go before the County Commissioners for a vote.

TOPIC: Clara Barton Memorial

DISCUSSION: Dan Spedden proposed to the Board that the CVB donate \$50,000 to the

Community Foundation for Tony Mendez to create the sculpture of Clara Barton and a solider in a battlefield scene (picture on file with minutes). Al Martin shared that those funds needed to be raised upfront before a bond bill could be

received.

MOTION: To donate \$50,000 to the Community Foundation for the creation of the Clara

Barton Memorial sculpture. 1st Angie Hummer, 2nd Teri Leiter

ACTION: Approved, with one abstention, Al Martin

TOPIC: The House on Jonathan Street

DISCUSSION: Dan Spedden recalled to the Board that he had originally proposed the idea of

donating \$100,000 towards the development of a public television documentary on the Jonathan Street Cabin. Mr. Spedden now proposed \$50,000 and ask the County to match from their lodging tax funds. The CVB would be recognized as an underwriter and sponsor and receive a fifteen (15) second audio and video

credit before and after each broadcast.

MOTION: To invest \$50,000 towards the development of a 60-minute, Public Television,

documentary on "The House on Jonathan Street" produced by Three Roads Communications, Inc., if the County is willing to match the funds. 1ST Angie
